6.0 m to 3.0 m and S. 10.4.6(a) of Zoning Bylaw No. 0154 to increase the maximum height of a single building wall from 9.0 m to 12.5 m; and

THAT Council approve a Floodplain Exemption under S.3.24.3(a) and (c) of Zoning Bylaw No. 0154 to permit a foundation to be setback within 15 m of Okanagan Lake and adjacent watercourse in accordance with the attached permit and flood hazard assessment report (*Attachment 1*), and subject to registration of an indemnity covenant with the City.
