DESCRIPTION / OVERVIEW

BACKGROUND:

We are pleased to announce that the **DRAFT** City of **West Kelowna Official Community Plan (2040)** is now available for formal review and comment.

West Kelowna is home to nearly 39,000 people and by 2040, we expect to welcome an additional 12,000 new residents to our community. The update of the Official Community Plan (OCP) will help guide growth and establish policies that make West Kelowna a great place to be and reflect the **Community Vision** established in 2021.

- Section 1 provides background and overview of the community context with linkages to the public engagement and Community Vision.
- Section 2 identifies the proposed land use designations and policies to guide development and to enact the Growth Concept which focuses most future growth in two urban centres, five neighbourhood centres and accommodates continued development beyond these centres with a focus on infill housing, as well as enhancing key economic opportunities in the City's industrial and business park areas.
- Section 3 highlights the fundamental objectives, policies and actions to meet the Community Vision from a broader context, and will guide the City's housing, business, infrastructure, and parks decisions for the next 20 years.
- Section 4 includes the identification of Development Permit Areas and Guidelines.
- Section 5 outlines implementation measures, including clarification of some procedural elements of the OCP and glossary of terms.

During the past two years, feedback from the community, stakeholders and key agencies helped create the shared vision, Growth Concept and Land Use Plan that will help make West Kelowna a vibrant, walkable and connected community.
