BYLAW NO. 0265.08

A BYLAW TO AMEND "ZONING BYLAW NO. 0265"

WHEREAS the Council of the City of West Kelowna desires to amend "CITY OF WEST KELOWNA ZONING BYLAW NO. 0265" under the provisions of the *Local Government Act*.

THEREFORE BE IT RESOLVED that the Council of the City of West Kelowna, in open meeting assembled, hereby enacts as follows:

1. <u>Title</u>

This Bylaw may be cited as "CITY OF WEST KELOWNA ZONING AMENDMENT BYLAW NO. 0265.08, 2022".

2. Amendments

"Zoning Bylaw No. 0265" is hereby amended as follows:

- 2.1 By changing the zoning of a portion of Lot 1 District Lot 2697 Osoyoos Division Yale District Plan 22919 Except Plan 33644, as shown on Schedule 'A' attached to and forming part of the bylaw from Rural Residential Small Parcel (RU2) to Single Detached Residential (R1).
- 2.2 By depicting the change on "Zoning Bylaw No. 0265 Schedule B" (Zoning Bylaw map).
