Highlights of the Regional Board Meeting – November 25, 2019

Revised Secondary Suites Bylaws

The Regional Board has rescinded the May 9th first reading of proposed amendments to secondary suite regulations and permitted zoning designations for both the RDCO Zoning Bylaw No. 871 and the Joe Rich Rural Land Use Bylaw No. 1195. In light of upcoming changes to the BC Building Code for secondary suites, the Board has now given first reading to updated amendment bylaws. The suite amendments would clarifv secondarv regulations and strengthen servicing requirements while continuing with the current process of the Board considering individual secondary suite applications. A Public Hearing will be scheduled and advertised for these proposed bylaw amendments.

Financial Plan Update

The Regional Board has received information from Financial Services staff regarding proposed new items that could be added to the 2020-2024 Financial Plan. This was an initial opportunity for Board Directors to review and discuss items of interest or concern while providing staff with preliminary direction as they prepare the first draft of the budget for mid-February presentation. Staff is directed to explore opportunities for enhancing the RDCO connection to and relationship with First Nations in the Central Okanagan and report back during budget deliberations.

Voting Unit and Board Composition Review

The Regional Board has directed the Chief Administrative Officer to start discussions with the Province and report back about potentially amending the Voting Unit structure and composition of the Regional Board. The number of directors and voting strength of each is based on population and the voting unit is specified in the Letters Patent for the Regional District. Currently the assigned Voting Unit value is a population of 4,000 and the Board has supported talking with the Province on using a Voting Unit of 6,000 people. That population number would change the City of Kelowna Board representation from seven to five members. Discussion about this governance matter arose as the Regional Board Strategic Priorities were being developed.

Regional Floodplain Management Update

The Regional Board has received an update on the second phase of the Regional Floodplain The latest work began last Management Plan. summer to assess and confirm the floodplains and alluvial fans for Trepanier Creek and Peachland Creek. Maps are being developed to show flood extents and elevations. When finalized, this information will help with future land use decisions, flood planning, risk assessment or other flood-related works.

Climate Change and Global Warming

The Regional Board has discussed a Notice of Motion regarding climate change and global warming. The Board supports further discussion and asked staff to report back on what the RDCO and member local governments are doing about climate change and to suggest local actions that can be taken along with any possible financial implications.
