5. MAYOR AND COUNCILLOR'S REPORTS

Council announced that the City of West Kelowna has sold 2570 Bartley Road to BC Housing for \$3.7 million, effective Oct. 31. BC Housing approached the City to help identify lands for various supportive, transitional and other social housing types. The City will lease the site from BC Housing and no changes to the existing Public Works Yard are expected until BC housing has provided its long-term development plan for the property.

The BC Municipal Safety Association has given the City of West Kelowna the 2023 Organizational Safety Excellence Award for leadership, dedication, and diligence in creating a safer and healthier workplace and helping injured workers recover and return to their jobs. Health, Safety and Wellness Manager Lisa Hoult was also awarded the Health and Safety Stewardship Award for extraordinary leadership in developing policies, procedures, tools, and communications in support of employees' wellbeing. Council thanked all staff for contributing towards keeping City workplaces safe and healthy.

Council invited the community to attend the Royal Canadian Legion Westbank Branch's Remembrance Day ceremonies in West Kelowna from 10 a.m. to noon on Saturday, Nov. 11 at Royal LePage Place. THAT Council deny the issuance of a Development Variance Permit (DVP 23-07) to exempt S.3.1.6 for frontage improvement (or cash in lieu) at time of subdivision to Glenrosa Road (rural arterial standard) and the unnamed access road (rural reserve local standard.
