Subject: Funding Strategies - Major Projects - Follow Up

### **PURPOSE**

To facilitate a discussion on funding options for major projects and seek direction on the next steps.

### **RECOMMENDATION** to Consider and Resolve:

**THAT** the 2024 Capital Budget Request for Pedestrian Infrastructure (C2024-27 – Multi Use Path Connections) be approved in the amount of \$380,000 funded from the Growing Communities Fund;

**AND THAT** the 2024 Capital Budget Request for Facilities (C2024-50 Arena - Score Clock Replacement and Gondola Expansion) be approved in the amount of \$600,000 funded from the Growing Communities Fund;

**AND THAT** the 2024 Capital Budget Request for Equipment – Fire Department (C2024-55 Fire Truck - Quint) be funded from MFA – Equipment Financing;

**AND THAT** Council approve the Operations Yard Project Budget of \$9,805,000 and related Funding Strategy as outlined in Attachment 7 in the report titled "Funding Strategies – Major Projects – Follow-Up" from the Deputy CAO, dated February 13, 2024.

# STRATEGIC AREA(S) OF FOCUS

**Invest in Infrastructure** – We will invest in building, improving and maintaining infrastructure to meet the needs of, and to provide a high quality of life for, current and future generations.

### **BACKGROUND**

The Strategic Priorities has four pillars to guide the use of resources and organize priorities. They are Invest in Infrastructure, Pursue Economic Growth & Prosperity, Strengthen Our Community and Foster Safety and Well-being. Under each of these pillars are specific priorities/projects. During the 2024 budget deliberations, there were six (6) projects identified for possible use of the Growing Communities Fund (GCF) funds. Council has already allocated GCF towards the Fire Hall #32 project and the Shannon Lake Roundabout project. Staff have pulled together additional information on the GCF (Attachment 1) to facilitate the discussion of options available. As Council considers the funding available from each of these options, it is important to consider the broader strategic priorities endorsed by Council.

### **DISCUSSION**

Each of the six (6) projects have been summarized and are attached to this report. The projects are as follows:

- 1. C2024-27 Multi Use Path Connections (Attachment 2)
- 2. C2024-43 Mt. Boucherie Community Center (MBCC) (Attachment 3)
- 3. C2024-44 Fire Hall #32 (Attachment 4) Note: This is the only project where Council has directed use of GCF out of these 6 projects
- 4. C2024-50 Royal LePage Place Score Clock and Gondola Upgrade (Attachment 5)
- 5. C2024-55 Quint Fire Truck (Attachment 6)
- 6. C2022-46 Operations Yard Project (Attachment 7)

In addition to the aforementioned projects, there are other Strategic Priorities of Council identified to begin within the current Council Term (through 2026) which include initiatives that Council may wish to discuss for future consideration of the Growing Communities Fund. The list below are examples of initiatives that may be either underway or anticipated to begin over the next couple of years and would require further direction from Council.

Examples that qualify for the Growing Communities Fund

- Returning the Mt. Boucherie Community Centre for public use
- Upgrading Johnson Bentley Memorial Aquatic Centre
- Sports Fields and additional Parks, including Dog Parks
- Upgrades to the Old Okanagan/Butt Road Intersection
- Pedestrian Improvements, including those aimed at making sidewalks more accessible
- Improvements to Elliott Road from Smith Creek Road to Reece Road
- Expanding the offerings at Memorial Park
- Increasing accessibility at civic facility gathering spaces

# **Growing Communities Fund**

On March 16, 2023 the City received notice from the Province establishing, and distributing, the Growing Communities Fund (GCF). The letter from the Province is attached (Attachment 1). The City of West Kelowna received \$10,212,000 from the GCF program and the monies were deposited into a separate statutory reserve, as required under the terms of the funding. The letter provides some detailed examples of what the funds can be used for, but there are a few overarching parameters to consider, as outlined in the body of the letter from the Province. These include, but are not limited to:

- ➤ The principal objective of the GCF is to increase the local housing supply with investments in community infrastructure and amenities.
- The funding provided through the GCF should be limited to one-off costs needed to build required infrastructure and amenities rather than funding ongoing or operational activities

As per the Province letter in Attachment 1, it is expected that the funds will be expended within approximately five years of receipt.

#### FINANCIAL IMPLICATIONS

# Growing Communities Funds Reserve:

The GCF were received and deposited into the general investment account with the City's bank (BMO) in late March 2023. After creating the GCF reserve In July the \$10.2 million was placed in a six-month GIC. The interest rates applied to reserves is a blend of rates from all investments and averages out to be 5.46% for 2023 (estimated).

As noted in the chart below, the GCF fund has already earned more than \$418,000 which is roughly equivalent to a 1% tax increase. Furthermore, for every 1 million dollars unspent, it earns just under \$55,000 in interest per year. Therefore, Council could elect to spend a portion of the funds in 2024 and invest the balance for continued to growth in the fund.
