

My wife and I have been residents of West Kelowna for the past thirteen years. For the most part we are satisfied with manner in which our tax dollars have been spent. Other then the ill planned and executed new city hall, poorly maintained older paved surfaces that just seem have been forgotten about with patches on top of parches and then more patches while resurfacing other paved roads that absolutely didn't require any work what so ever ! In addition to this I was and still am absolutely befuddled on how the city plans the street lighting. It has continues to be consistently inconsistent. Many areas would be deemed outright dangerous by other provincial communities no less national lighting standards. What ever department designs the street lighting needs to be abolished and reorganized with competent

engineers, or at the very least seek and obtain updated training. Not including Hwy #97, West Kelowna's street lighting is atrocious. I have observed reasonable lighting designs here and there but they are consistently inconsistent . These range from NO lighting where there needs be at least some, poor uniformity ratios, tiger striping, incorrect standard heights, incorrect standard spacing and placement and a mixture of different luminaire types and patterns. If I had designed or allowed any of these to be constructed I would have lost my job. In my experience West Kelowna would benefit from a planned yearly budget over perhaps five to eight years to rebuild and standardize the entire city.

We do not want to hear supply chain issues as it seems private sector can get their buildings completed on time and on budget. Our taxes were based on the assessment value of our homes - taken when the home prices were at the absolute peak in the market. So we did not just pay a 6.75 Increase in 2023 as our rates were based on a much higher amount than previous years. Why should us tax payers be subject to a 8.35% increase when such a gross over spending has happened. See alot of waste and over expenditures. We do not need a sidewalk on both sides of Shannon Lake Rd - we need traffic control - roundabout that was slated for Tallus Ridge over 8 years ago - another one needed on Smith Creek rd. How about we worry about making roads usable instead of just looking good. We do not want another Boucherie rd fiasco. Make roads wide enough for buses, fire trucks etc. a bike lane can go next to a sidewalk so as to take up less space. Under emission reduction projects it says we need to contribute \$114 000 to qualify for the provincial funding. Why is our total \$614 000. Why an extra \$500 000. \$179 463 is alot of money for two way radios when everyone has a cell phone. I would soon see the \$70 560 being spent on AI be spent

on real people with real jobs who actually contribute to our community. You have \$50 000 in the budget for storage of equipment and materials - I thought Cristy Clark gave us that land to be used as a public works yard. Do we really need a \$40 000 side by side. I see a lot of trucks driving around that should easily be able to make it into the water treatment area. And on the next page it even goes to say how you need a plow to go on one of those trucks.


