On behalf of Interior Health, we are pleased to support Kelowna Gospel Mission's proposed Westside Resource Hub.

People experiencing homelessness are at higher risk of poor physical and mental health outcomes and premature death. Unhoused individuals can experience significant barriers in accessing services which may result in the worsening of their health and well-being. Often marginalized individuals have limited access to hygiene facilities, increasing their risk of communicable disease and wound infections. The proposed Westside Resource Hub will provide access to clean washrooms and hygiene facilities and will help connect individuals to social and health supports. Having this service near public transportation further supports individuals to access and connect with other parts of the community, helping to address social isolation.

Interior Health collaborates with local governments and community partners to improve health and wellness by helping create policies that support healthy environments and behaviours. It is our experience that Kelowna Gospel Mission is committed to working collaboratively with Interior Health and other partners to improve the health of their clients and foster a sense of community. To the City of West Kelowna Council Members

The Central Okanagan Food Bank in West Kelowna has been participating in the meetings to solve issues around the unhoused people in this community. Through these meetings it has become painfully obvious that more services are needed in West Kelowna, particularly resources providing support for those coming off the streets, a place to find reprieve and to receive healthy meals.

In mid-2023 the West Kelowna branch of COFB began tracking the number of day bags (a sandwich, a drink, and a granola bar) that we give out. In September 2023 we handed out 47-day bags. In February 2024 we handed out 151-day bags, quite a significant increase. The reason for this increase is because there has been a decrease in options for meals by service and not-for profit providers. Many of the people we serve have substance use issues and mental health issues.

Many of our unhoused clients report that they can't travel to Kelowna due to transportation barriers and don't like the feeling of being displaced outside their community. Further, many unhoused folks can be seen on our security cameras digging through our dumpster. They are eating food that is not meant for human consumption. During the fires in September and throughout the summer we provided water to the unhoused people; on hot days these people struggle to get out of the heat, and they breathe in unhealthy air. In the winter they put themselves at great risk sleeping outside in freezing cold temperatures. In the months when things begin to warm up their feet are often wet, and when the evenings cool off, they are at risk of hypothermia.

The West Kelowna community needs a place where outreach workers and other service providers can meet with clients and support them to access needed services; support groups need a place to meet, and we need a safe place for people to access hygiene services and healthy meals. West Kelowna also needs to provide sufficient emergency housing to avoid having a tent city.

This food bank is hoping to support such an organization by providing sandwiches, granola bars, just add water soups, drinks, bulk items that we have in excess (food, toiletries, socks, gloves, toques, blankets etc.). We frequently have nonfood items donated to us and we would be happy to share those with a Resource/Hygiene Centre. A key focus that a resource center would provide is to provide a hot soup and a warm meal. This meal creates a sense of connection and opportunity where the resource team can address the complex care issues that the unhoused community is experiencing. Through this connection, clients are encouraged to seek a housing solution and to get back to a safe place and housing environment. The foodbank staff and volunteers are not equipped to take on this important task but are willing to support this initiative with the resources we have.

Based on the need for connection, we recommend the launch of a community-collaborated resource center that connects with the unhoused population in the West Kelowna community.

RE: West Kelowna Housing and Homelessness Resource Hub

To the City of West Kelowna Council Members

United Way BC has been engaged in a series of meetings to better understand the landscape of unhoused and underhoused populations in the West Kelowna area. Since 2023 and through the wildfire event in 2023 there have been a significant number of people experiencing housing precarity; this has increased significantly since COVID-19 and is exacerbated by the ongoing intersecting crises of cost of living, housing, climate related events and toxic drug supply. United Way BC is aware of similar situations across communities in BC.

In the Central Okanagan the vast majority of services for the unhoused are in Kelowna and with this growing population of folx needing support and assistance there is a need to decentralize that support as well as making the supports more accessible to people without private transportation. The priority areas of need as identified by the West Kelowna Housing and Homelessness Table is for immediate access to support services such as health care, mental health supports and housing. Additionally, the need for a single place to access healthy and nutritious food is essential and lastly identifying somewhere for unhoused and underhoused people to seek shelter from the elements is crucial.

Currently these services are being provided in an ad hoc manner through piecemeal funding; the people being served are community members and residents and are in the unfortunate situation of losing their housing for a multitude of reasons. United Way BC has recently released a report highlighting the impact of the housing crisis on seniors and other people on a fixed income (Aging in Precarity); we are also aware that many of the people who are unhoused are families or people with disabilities. In order to achieve a healthy, caring and inclusive community we must grapple with the systems in which we operate to provide accessible, culturally safe and trauma informed care for all community members.

United Way BC is a connector and convenor of the non-profit sector in this region; we have heard from many partners that the struggle to provide water and shelter for the unhoused population is a growing challenge. Having a single space where people can go to access these basic human rights and a space where social service sector providers can triage and support individuals is a key stepping stone on the path to addressing and preventing homelessness in the communities where we live and work.
