RE:

Pedestrian Improvement Program – Program Update

RECOMMENDED MOTION:

THAT Council direct staff to select pedestrian improvement projects based on *Fig 4. Updated Project Priority List* as part of the City of West Kelowna's Pedestrian Improvement Program.

RATIONALE:

A detailed review of the previously adopted 10-Year Pedestrian Improvement Program was recently conducted taking into account various criteria including but not limited to: the City of West Kelowna's Pedestrian and Bicycle Infrastructure Plan, staff observations and recent resident feedback. The prioritized projects noted within the previously adopted plan are currently on schedule, largely due to increased investment made by Council in January 2018 from \$600,000 per year to \$1,200,000 per year. This report identifies an updated project list utilizing the increased budget and up to date decision criteria.

BACKGROUND:

Boulevard Transportation was engaged in 2014 to develop a Pedestrian and Bicycle Infrastructure Plan to assist in prioritizing short, medium, and long-term improvements required for active modes of pedestrian transportation. The Pedestrian and Bicycle Infrastructure Plan prioritized projects based on their proximity to major trip generators such as transit, schools and town centres. Taking into account feedback from residents and Council at the time, short-term priorities focussed on improvements to areas within close proximity to schools. The Pedestrian and Bicycle Infrastructure Plan was adopted on February 9th, 2016.

Upon review of the various project segments noted within the plan, a list of prioritized projects was developed for the 10-Year Pedestrian Improvement program. The improvements were developed with direct reference to the Pedestrian and Bicycle Infrastructure Plan, staff observations and utilizing feedback from both the public and Council at the time. The intent of the program was to improve network connectivity throughout the City and increase public safety.

Pedestrian improvements encompass a large project scope consisting of concrete sidewalks, concrete curbs, storm improvements, street lighting enhancements, asphalt remediation, landscape restoration and line painting.

The 10-Year Pedestrian Improvement Program identified a project priority list which was presented to Council at the January 24th, 2017 council meeting. With a priority placed on improving pedestrian infrastructure within close proximity to schools, the following project list was finalized and adopted by Council (C136/17):

Since adoption of the prioritized list, the noted projects along Webber Road, Daimler Drive and Ross Road have all been completed on time, on budget and within the originally established schedule. The completed projects have all been well received by the public as safety within each neighborhood has increased considerably.

A major contributing factor to the successful completion of the noted projects to date was Council's commitment to increase the program budget from \$600,000 per year to \$1,200,000 per year during the Council meeting held on January 16th, 2018 (C047/18). The increased budget has allowed for accommodation of escalating construction costs, project scope increases and ultimately maintaining the program schedule.

PROGRAM UPDATE

With the successful completion of the program to date, a thorough review was recently conducted taking into account various decision-making criteria including:

- 10-Year Capital Plan
- Sanitary Master Plan
- Pedestrian & Bicycle Master Plan
- Resident requests and concerns
- Feedback from Parks and Operations Staff
- Road Rehabilitation Program
- Transit Routes
- **Network Connectivity**

With the focus remaining on proximity to schools within the City, the short-term priorities remain unchanged. McIver Road is tentatively scheduled to be completed in 2020 as part of the capital improvements to Glenrosa Road. New sidewalks to Webber Road (between Malcolm Road and Gorman Road) and to Brentwood Road (between Ross Road and Alhambra Drive) should follow.

Referencing the original project priority list identified in Fig. 1, project completion dates were noted as "TBD" following completion of pedestrian improvements to Brentwood Drive. Taking into account the previously noted decision criteria, locations along Horizon Drive and Westlake Road/Parkinson Road have generated the most concerns from the public. Staff observations have identified Gates Rd (between Stonegate Court and Glenrosa Road) approaching Helen Gorman Elementary as an area of need. In addition, staff have also observed Old Okanagan Highway (between Dobbin Road and Ingram Road) adjacent to Johnson Bentley Aquatic Center as an area seeing a high volume of pedestrian use.

It is important to note that several areas along arterial roadways have also been identified as problem areas, specifically locations on Gellatly Road South, Shannon Lake Road and Parkinson Road. Improvements to these areas will be made in subsequent years through funding from the Arterial Roads Improvement Program. The Pedestrian improvements program referenced within this report focusses on areas located along collector and local roadways.

Pedestrian Improvement Program - Program Update

Taking into account the recent conclusions, in addition to spreading the construction impact evenly across the City, an amended project priority list has been identified below for Council's consideration:

FINANCIAL IMPLICATIONS:

With continuation of a program budget of \$1,200,000 per year, there will be sufficient funds to complete the projects noted within the updated priority list on a year-to-year basis. In any year, if actual construction costs are lower than the approved budget of \$1,200,000, the excess funding will be carried over to the following year to target larger sections of sidewalk that require the additional funding (Gates Road, Horizon Drive). If in any year, the budget is reduced for the pedestrian improvement program, the projects in the priority listing (Fig. 4) will be amended accordingly.
