## **PURPOSE**

To provide Council an update on the Green Bay Local Area Service for Safe Boat Navigation.

## **RECOMMENDATION** to Consider and Resolve:

**THAT** the report titled "Green Bay Local Area Service for Safe Boat Navigation" dated December 10, 2024 from the Acting Director of Engineering & Operations, be received for information.

## STRATEGIC AREA(S) OF FOCUS

**Invest in Infrastructure** – We will invest in building, improving and maintaining infrastructure to meet the needs of, and to provide a high quality of life for, current and future generations.

#### BACKGROUND

Owners of the Green Bay community approached the City of West Kelowna to inquire about utilizing a Local Area Service process (LAS) to undertake a two (2) phase approach to improve the navigable channel for safe boat access to the neighborhood. The bay has become too shallow for safe boat navigation during low water periods, and even during the boating shoulder seasons. The LAS affects 40 properties in total as outlined in Bylaw No. 0309.

In Phase 1 staff worked directly with the appointed residents, Arsenault Environment Consulting Ltd, and Tetra Tech Canada Inc to evaluate the environmental, financial and construction probabilities of the dredging project. A Section 11 Change Approval is in

progress and will be in place before the work commences. Timing for the works is anticipated for early March to be completed by the end of April 2025.

The scope of Phase 2 of the works includes:

- Dredge up to 2,850 m³ of sandy material (with some organic components) out of the bay.
- Employ a silt curtain around the dredging area to meet the criteria set out in the environmental management plan. The curtain would contain turbidity created by dredging activities.
- Move the material to a dewatering area where the material will be spread for drying.
- The material will then be trucked to a nearby disposal area.
- Environmental and Engineering monitoring will be completed during the dredging work.

Prior to initiating phase two, a petition will need to be completed to determine if residents support continuing the project. Under the Community Charter, s. 212, for a petition to be sufficient, over 50% of total affected owners and more than 50% of the total values must be submitted. The Corporate Officer must determine the sufficiency and validity of a petition to Council and must certify this determination. This petition process is planned to be completed in January, with a report to Council following the completion of a successful petition and to create a Local Area Service Bylaw.

## FINANCIAL IMPLICATIONS

The entire capital costs of the project will be the responsibility of the benefiting area. The estimated total cost that will be petitioned to residents for Phase 2 is \$950,000, which includes a contingency to account for potential scope changes. These costs will be recovered through a local service tax parcel tax, outlined under s. 216 of the Community Charter, and will be divided equally among the affected property owners. It's important to note that two of the 40 affected properties are owned by the City.
