My Name is Ken England , my Wife Lynne and I reside at 213-3870 Brown Road in The Monticello Complex , which is directly across from the subject property at 3887 Brown Road. We were advised some time back that the city would be installing poles along the south side of Brown Road as a buffer to the walking lane but to date nothing has been done. Traffic is already quite heavy when there are events at the cidery and the adjacent wine tasting facility and if approved the new special event area will undoubtedly increase the levels. We feel strongly that the installation of an extension to the sidewalk from the Miravista complex to the south east end of the subject property at 3887 Brown Road is necessary for the safety of pedestrians. I would note that when the cidery has large functions and their parking lot is full , the overflow parks along Brown Road and the situation worsens. Patrons that have enjoyed several drinks often leave the property at higher that allowed speeds increasing the potential for accidents and danger to walkers.

It may well be necessary for a regulated cross walk as well as speed bumps to alleviate this problem. Thank you for the opportunity to express our concerns.

As residents of Brown Rd. We have quite a few reasons why this proposal should not move forward.

- 1 The south end of Brown Rd. already has a lot of traffic from the 5 Condos.
- 2. This road is used by walkers, cyclists, runners, and mobile device users and the lack of an adequate sidewalk especially in winter when the snow plows push the snow off of the road and onto the designated sidewalk (marked by a painted line). The only recourse is to walk on the road as the other side of the road is lined with parked cars. These cars are always there regardless of the time of day.
- 3 There should be traffic softening speed bumps on this road because of the speed many of the motorists drive.
- 4 There will be even more than enough traffic on the road once the construction of the multi-Family development starts.

We are residents of Monticello, in a condo that faces Brown Road and Truck 59 Cidery. This location places us on the front line of vulnerability to the activities that occur at Truck 59. The proposed amendment to their liquor license is therefore of grave concern to us.

Truck 59 is almost exclusively <u>an outdoor venue</u>. Amplified music, played over speakers placed on the south lawn area, is a constant problem for us. The music is audible from our condo, all day, even when we are indoors with windows closed.

We have attempted to reach out to Truck 59 in the spirit of finding a respectful compromise. We have suggested turning down the bass, because enduring the pounding drum beat all day becomes anxiety and stress inducing. We have thanked them when the speakers are not placed out on the lawn (apparently due to rain), as the music is more tolerable for us (even though <u>no outdoor amplified music</u> would be our preference).

Events are even worse, adding amplified MCs, loud dance/party music. Again, all of these activities <u>take place outside</u>. Up until now, these special events were generally for a few hours in the afternoon, or, in the case of a wedding reception, began in early afternoon and didn't wrap up until well into the evening.

Our efforts have been met with indifference by Truck 59. A visit from a Bylaws officer at our request, and speaking with staff in person have been shrugged off. Nothing has changed. They are unwilling to show reasonable accommodation, even as we have tried to find a cooperative solution with them, ie: adjusting music volume, placement of speakers in more appropriate location.


As we head into patio season, we are already bracing ourselves with having to endure the relentless noise that we cannot escape, even inside our home. The amendment to allow them to be open until 10pm, seven days a week, is untenable.

We appeal to Council to reject the expanded liquor and event license on the grounds that Truck 59 has not demonstrated that they are a good neighbour. Truck 59 should not be rewarded, given their lack of respect for their neighbours.

Would any of you endorse what is in effect an all-day, seven-days-a-week, outdoor bar, playing amplified rock music next to your home in a residential neighbourhood?
