

CITY OF WEST KELOWNA
BYLAW NO. 0095.55
A BYLAW TO AMEND TICKET INFORMATION UTILIZATION

WHEREAS the *Community Charter* empowers the City of West Kelowna, by bylaw, to designate those bylaws for which municipal ticket information may be used as a means of bylaw enforcement; and

WHEREAS the *Community Charter* empowers the Council to, by bylaw, set fine amounts; and

WHEREAS the Council of the City of West Kelowna desires to amend Bylaw No. 0095; and

THEREFORE BE IT RESOLVED that the Council of the City of West Kelowna, in open meeting assembled, hereby enacts as follows:

1. Citation

This bylaw may be cited as “City of West Kelowna Ticket Information Utilization Amendment Bylaw No. 0095.55, 2025”.

2. Amendments

“City of West Kelowna Ticket Information Utilization Bylaw No. 0095” is hereby amended as follows:

- 2.1 By deleting “District of West Kelowna Traffic Bylaw No. 0092, 2009” reference from number 16 in the Table of Contents, and replacing it with “City of West Kelowna Traffic Bylaw No. 0331, 2025”.
- 2.2 By deleting Schedule 16 – Ticket Offences for City of West Kelowna Traffic Bylaw No. 0092 in its entirety and replacing it with a new Schedule 16 as per Appendix A, attached to and forming part of this bylaw.
