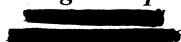


## Active Living Entreprises Ltd.

#### Dear Bob:

I've recently sent you the final "<u>Financial Operating Statement</u>" for JBMAC Pool for the year 2019 provided by WK Group Accounting and Joe Maciel Accounting of West Kelowna, B.C.

As you know from our meeting in early Fall, the financial information available to us at the time, indicated a possible shortfall of budget by December 31, 2019 (the fiscal year-end).

Following this meeting, Active Living Entreprises Ltd. promised to put a plan into place to try and mitigate the anticipated budget shortfall, to the best of our ability, as indicated in our meeting with you, Erin, Lisa and Warren in early October.

Much to our surprise, it appears we were successful in "turning-the-tide" and ended up with an operating surplus instead of a deficit, contrary to our earlier forecast.

There were several actions that went into place in order to create this turn around, all with the intention of just balancing the budget. So, you can imagine our joy when we found out we actually created an operating <u>surplus of \$27,494</u>.

It is with the aforementioned in mind, that I now draw your attention to Clause 9.1 and 16.1-16.4 of our current Management Agreement, which in short, provides Active Living Entreprises Ltd. with a vehicle in which to request a 50% share of the 2019 year-end operating surplus, or \$13,747.

We appreciate you putting our request forward to City Council for their consideration as per Clause 16.3 & 16.4 of the Management Agreement.
