
Highlights of the Regional Board meeting – June 28, 2021

2020 Financial Disclosure Schedules

The Regional Board has approved the 2020 report outlining remuneration and expenses for elected officials, their alternates and 41 staff whose remuneration was greater than \$75,000. In 2020, the remuneration of all Regional District employees totaled just over \$9.4-million. The report also outlines payments totaling over \$14.4-million during 2020 to 96 suppliers for goods and services exceeding \$25,000.

Financial Plan amendment

The Regional Board approved an amendment to the 2021-2025 Financial Plan. It will see \$35,000 allocated in 2021 for Regional Parks capital asset management software used for capital purchases of trucks and equipment.

Agricultural Land Commission application

The Regional Board does not support and will not forward a non-farm use application for consideration of the Agricultural Land Commission (ALC). The owner of a property at 2770 Schram Road applied to the ALC to use a portion of an existing barn on the property for commercial storage. The Board supported staff's recommendation and did not support the application in light of a bylaw complaint and concerns of a number of agencies about storage of vehicles that resulted in a letter from the ALC requiring an immediate cease of non-farm uses at the site.

Planning Applications Considered

The Regional Board considered the following planning applications:

- The Regional Board did not give **2nd & 3rd readings** to **Zoning Amendment Bylaw No. 871-268 (Application Z21/03)** for 5631 Rittich Road (A. & C. Patton, owners).
- **Adoption of Zoning Amendment Bylaw No. 871-266 (Application Z21/01)** at 5060 Whelan Road (L. & D. Ketler, owners) – A site specific amendment to permit an accessory home on the property within the Agricultural Land Reserve.
- **Adoption of Zoning Amendment Bylaw No. 871-267 (Application Z21/02)** for 7155 Dunwaters Road (J. & S. White, owners) - To add a secondary suite within a single detached house on the property.
- **Conditional approval of Development Permit Application (DP-21-06)** for 7174 Fintry Delta Road (Narasak Holdings Ltd. & K. Souter, owner) – To permit works associated with the relocation of an existing unauthorized accessory structure and habitat restoration. The permit is conditional on the applicant meeting a list of conditions.
