What is Your Request to Council: PLEASE REJECT THIS APPLICATION TO GET A
TEMPORARY RE-ZONING

Presentation Points (please provide a brief outline):

- Research has shown that silica from gravel mining can degrade air quality as far as 750 meters away, leading to a variety of serious health problems. This proposal will place a 42-bed shelter in the middle of mining activity!
- 315 homes are in the area with mostly retirees that bought their homes here for reasons of affordability and tranquility that comes with being out of the downtown core.
- We have had to put up with the dust and noise and sulfurous odors that are part of an industrially zoned area and now you are asking us to put up with even more disruption. It is unacceptable!
- The services that these folks need are so far away and its ridiculous to assume they will take the initiative to travel to access them
- We have already seen people with carts going to the green spaces offered by Brookhaven Care Centre and when they have to get away from the noise and harmful dust of mining activity and the odors from asphalt heating they will migrate to places that offer escape.
