RECOMMENDATION

THAT Council resolve to adopt the City of West Kelowna Rose Valley Water Treatment Plant Temporary Borrowing Bylaw No. 0289, 2021.

STRATEGIC AREA(S) OF FOCUS

Invest in Infrastructure – The Rose Valley Water Treatment Plan is considered a priority project in Council's Strategic Priorities.

LEGISLATIVE REQUIREMENTS

As provided by the *Community Charter* Section 181, a Council that has adopted a loan authorization bylaw may, by bylaw, temporarily borrow money not exceeding the difference between the total amount authorized by the loan authorization bylaw and the amount already borrowed in relation to that bylaw. To the extent necessary, the proceeds of the borrowing under Section 182 must be used to repay the money temporarily borrowed.

DISCUSSION

Adoption of the temporary borrowing bylaw allows the City to move forward with the main funding phase of the Rose Valley Water Treatment Plant Project while balancing cash flow and grant usage. As invoices are submitted and accepted by the City, the temporary borrowing regime allows for numerous draws on the debt throughout the project as needed. It is also important to reiterate that in the event the project comes under budget only the actual cash outlay would be converted to long-term debt thereby saving rate payers money in the long-term.

Next Steps - Short Term Borrowing for Infrastructure and City Hall Temporary Borrowing

Temporary borrowing for the Rose Valley Water Treatment plant as compared to overall borrowing is completely focused on the budget for the water utility and is directly tied to published water rates with no effect on the general budget.

Upcoming planned borrowings are centered on the general budget and are tied to facilities and pedestrian infrastructure. The next step for staff is to bring a bylaw forward utilizing the 1% infrastructure levy as an annual payment to support short-term borrowing for pedestrian and multi-use infrastructure. At the current five-year rate of 0.93% using the \$360,500 infrastructure levy as a yearly payment, just under \$1.8 million is available through the Municipal Finance Authority's short-term borrowing program.

1% Infrastructure Levy Short-term Borrowing:

The following chart is a summary of projects the 2021 Levy is projected to support:

Later in the third quarter there will be another report and bylaw coming forward covering the temporary borrowing required for the construction of the City Hall project. The timing will be somewhat flexible on acquiring and drawing on such debt since the funding sources include the City Hall reserve.

FINANCIAL IMPLICATIONS

Temporary Borrowing:

Since starting the main construction phase of the water treatment plant project, cash outlay has accelerated with the City receiving its first few progress invoices totaling just over \$1 million to date. We have also been utilizing provincial and federal grant money to cover much of the design and early works costs in the interim and will need to draw on debt soon to recover the City's portion not covered by grants.
