THAT Council authorize the issuance of a phased Development Permit (DP 21-17) for the development of fifty-eight (58) townhouse units with an attached amenity space within 5 buildings, including seven (7) additional townhouse units in a sixth building in an optional phase for a total of sixty-five (65) units on Lot A, DL 2601, ODYD, Plan EPP80014 subject to the conditions outlined in the attached Development Permit; and

THAT Council authorize a variance to the City of West Kelowna Zoning Bylaw No. 154 in accordance with the attached Height Variance Drawing No. DD9.1, as follows:

 That the maximum building height (s. 10.9.5(f)) be varied to allow a rooftop patio access over the 3 storey maximum for the amenity building and townhouse units with an associated increase in height from 9.0 m to 12.87 m; and

THAT issuance of the Development Permit be withheld pending receipt of:

- Landscaping security for Phase 1 of the landscape plan in the amount of \$323,090.50; and
- Park improvements security in the amount of \$310,574.06; and

THAT if the Development Permit has not been issued within one year from the date of approval, the Permit with variances shall deemed to have been refused and the file closed.
