

CITY OF WEST KELOWNA TEMPORARY USE PERMIT TUP 19-02

To: DDD Cable Friends Inc. c/o Andrea Loudoun #106 – 1680 Ross Road West Kelowna. BC V1Z 1L9

- 1. This Permit is issued subject to compliance with all of the Bylaws of the City of West Kelowna applicable thereto, except as specifically varied or supplemented by this Permit.
- 2. This Permit applies to and only to those lands within the City of West Kelowna described below, and any and all buildings, structures and other developments thereon:

Lot 2, DL 507, ODYD, Plan 15908, Except Plan H17081 (1680 Ross Road)

- 3. The conditions of the Temporary Use Permit (TUP 19-02) are as follows:
 - a. That the wholesale sales and major repair (structural and mechanical) of vehicles be permitted on the aforementioned parcel for a period of three years;
 - b. The fenced area and associated landscaping is not permitted to encroach within the Highway 97 Right-of-Way;
 - c. That the activities associated with the temporary use cease following expiration of the temporary use permit; and,
 - d. Landscaping and solid screening installed in in conjunction with the TUP shall be installed and maintained for entire 3 year duration as a condition of this permit.
- 4. The land described herein shall be developed strictly in accordance with the terms and conditions of this Permit and any plans and specifications attached to this Permit, which shall form a part hereof.

Security

- 5. As a condition of the issuance of this permit, the property owner shall deposit 125% of the cost estimate to ensure the installation of landscaping as screening (\$1,413.23) as Performance Security.
- 6. This Permit is not a Building Permit.
- 7. Subject to the terms of the permit, where the holder of a permit issued under the *Local Government Act* does not substantially commence any construction with respect to which the permit was issued within two years after the date it is issued, the permit lapses.
